1. This appeal is filed to challenge the order passed by the Whole

Time Member ("WTM" for short) of Securities and Exchange Board of

India ("SEBI" for short) on August 26, 2015. By the said order the

appellants are inter alia restrained from accessing the securities market

and are prohibited from buying, selling or otherwise dealing in securities

market for a period of four years and directed to wind-up the schemes

and refund the amount to the investors.

2. Counsel for the appellants state that the appellants have accepted

the decision of SEBI and have already started implementing the

impugned order and that SEBI is monitoring the refunds effected by the

appellants.

3. In these circumstances, nothing survives in the appeal and the

same is disposed of accordingly. Appellants are directed to co-operate

with the SEBI and ensure that the impugned order is implemented as

expeditiously as possible.

4. Appeal is disposed of in the aforesaid terms with no order as to

costs.
