adjusted towards the court fees payable on the fresh appeal.

of 2 weeks from today, fresh appeal that may be filed by the appellants shall

not be entertained.

4. We further make it clear that disposal of the appeal shall not preclude

SEBI from implementing the impugned order.

5. The Miscellaneous Application as also the Appeal are disposed of in the

aforesaid terms with no order as to costs.
