1. This appeal is filed to challenge the confirmatory order passed by the Whole Time Member ('WTM' for short) of Securities and Exchange Board of India ('SEBI' for short) on March 23, 2015 whereby the directions contained in the ex-parte ad-interim order passed by the WTM of SEBI on September 24, 2014 have been continued till further orders.

2. Counsel for SEBI on instruction states that investigation in case of appellant would be completed within a period of three months from today and if deemed fit show cause notice would be issued within a period of two weeks thereafter. Above statement made by counsel for SEBI is accepted. It is made clear that if the investigation is not completed and show cause notice is not issued within the time stipulated hereinabove, then, on expiry of $3\frac{1}{2}$ months from today, the impugned order shall come to an end without reference to this Tribunal.

3. Appeal is disposed of in the aforesaid terms with no order as to costs.
