CORAM: MADHABI PURI BUCH, WHOLE TIME MEMBER ORDER

Under Sections 11, 11(4) and 11B of the Securities and Exchange Board of India Act, 1992 in the matter of Moryo Industries Limited.

- Securities and Exchange Board of India ("SEBI") conducted an examination into the dealings in the scrip of Moryo Industries Limited ("Moryo" or the Company) on BSE Limited ("BSE") during the period from May 22, 2013 to January 30, 2015 as there was huge rise in the traded volume and price of the scrip.
- 2. Upon preliminary inquiry, SEBI prima facie observed the following:
 - MIL made preferential allotment of its 63,50,000 shares at the price of Rs 25/- per share to 42 persons (including joint allottees) on November 09, 2012. Subsequently, each share of Moryo was split into two shares on January 15, 2013;
 - After the release of compulsory lock-in period, the price and volume of the scrip of MIL increased substantially on account of trading amongst the Preferential Allottees and the Moryo Group entities (i.e. entities related/connected to Moryo and/or were instrumental in the price rise and/or contributed volume in the scrip of Moryo) and most of the Preferential Allottees were provided exit at a high price by the Moryo Group entities;
 - By virtue of the same, it was alleged that Moryo and persons in charge of its affairs created preferential allotment of shares as a mode to provide fictitious long term capital gains ("LTCG") to its Preferential Allottees so as to convert their unaccounted income into accounted one; In the process, Preferential Allottees and the Moryo Group entities artificially increased the volume and price of the scrip and misused securities market system for making illegal gains and to convert ill-gotten gains into genuine one to avail LTCG benefit.
- 3. As the aforesaid activities of Moryo and its Promoter/Directors, Preferential Allottees, Moryo Group entities were *prima facie* in violation of SEBI Act, 1992 ("SEBI Act") and SEBI (Prohibition of Fraudulent and Unfair Trade Practices relating to Securities Market)

Regulations, 2003 ("**PFUTP Regulations**") SEBI passed an *Ad interim ex-parte* order dated December 04, 2014 ("*interim order*") and restrained the following entities including Moryo and its Promoters and Directors from accessing the securities market and further prohibited them from buying, selling or dealing in securities, either directly or indirectly, in any manner whatsoever, till further directions.

- 5. The directions against the remaining 88 entities were confirmed vide Orders dated March 18, 2016 and August 22, 2016.
- 6. Pursuant to the interim order, SEBI conducted a detailed investigation of the entire scheme employed in the instant matter, connection amongst the debarred entities, funds

used for the price manipulation of the scrip of Moryo, etc., so as to ascertain the violation of securities laws.

7. Upon completion of investigation by SEBI, it is noted that investigation did not find any adverse evidence/findings against 85 entities in respect of their role in price manipulation in the scrip of Moryo warranting continuation of action under Sections 11B and 11(4) of the SEBI Act. Hence, violation of provisions of SEBI Act and PFUTP Regulations, etc., were not observed in respect of the following entities.

8. Considering the fact that there are no adverse findings against the aforementioned entities with respect to their role in the price manipulation in the scrip of Moryo warranting continuation of action under Sections 11B and 11(4) of the SEBI Act, I am of the

considered view that the directions issued against them vide interim order dated December

04, 2014 which were confirmed vide Orders dated March 18, 2016 and August 22, 2016,

are liable to be revoked.

9. In view of the foregoing, I, in exercise of the powers conferred upon me under Section 19

of the Securities and Exchange Board of India Act, 1992 read with Sections 11, 11(4) and

11B of the SEBI Act, hereby revoke the Confirmatory Orders dated March 18, 2016 and

August 22, 2016 qua aforesaid 85 entities (including joint allottees tabulated at paragraph 7

above) with immediate effect.

10. The revocation of the directions issued vide the abovementioned orders (at paragraph 9) is

only in respect of the entities mentioned at paragraph 7 of this order in the matter of

Moryo Industries Limited. As regards remaining 3 entities in the scrip of Moryo, violations

under SEBI Act, SCRA, PFUTP Regulations, etc., were observed and SEBI shall continue

its proceedings against them. Hence, the directions issued vide Order dated August 22,

2016 against remaining 3 entities viz., Moryo Industries Limited (PAN- AACCM5166G),

Manoharlal Saraf (PAN- AAIPS7577C) and Geeta Manoharlal Saraf (PAN-

ANMPS6842B) shall continue.

11. A copy of this Order shall be served on the Stock Exchanges and Depositories, for

necessary action.
