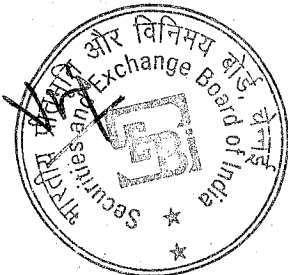

Subject: Remittance of attached amounts vide Attachment proceeding No.5947 and 5948 of 2020 Bank / Demat Accounts and Mutual Fund Folios

1. It may be recalled that the Recovery Officer vide the subject attachment proceedings in Recovery Certificate Nos. **2975 of 2020** dated August 17, 2020, had directed attachment of bank / demat accounts and mutual fund folios of **M/s. Sanraa Media Limited (PAN- AAACS9093A)** ["Defaulter"] against the total due of Rs.11,07,86,973/- (Rupees eleven crores seven lakhs eighty six thousand nine hundred and seventy three only) with further interest, all costs, charges and expenses etc., incurred in respect of recovery of the said dues.
2. Whereas Notices of Demand dated August 17, 2020 have been sent to the Defaulter demanding payment of the aforesaid dues and Notices dated September 11, 2020 for Attachment of Bank/Demat Account and Mutual Fund Folio(s) have been issued to you.

 - ii) redeem the units of mutual funds held in the name of the defaulters and remit the amount to the extent of dues as mentioned in para 3 above

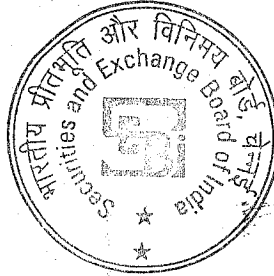
