- 2. And whereas a Notice of Attachment dated December 13, 2021 under the above proceedings was issued attaching bank, demat accounts/lockers and mutual fund folios of the entity.

And whereas in appeal no. 1026 of 2022 (Mr. Balvir Singh vs Securities and Exchange Board of India), Mr. Balvir Singh challenged the order dated 22.02.2021 passed by the Adjudicating Officer before the Hon'ble SAT which vide its order dated 04.01.2023 allowed the appeal and remitted the matter to AO to pass a fresh order in accordance with law after serving the show cause notice and after giving an opportunity of hearing.
- 4. In view of the above, you are hereby directed to release bank, demat accounts/lockers and Mutual Fund Folio etc. of Mr. Balvir Singh (PAN: AAAPS5463P) attached, if any, pursuant to the above notice of attachment with immediate effect.
