Whereas Recovery Certificate No. 3583 of 2021 dated April 26, 2021 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum Rs.10,85,822/- (Rupees Ten Lakh Eighty Five Thousand Eight Hundred Twenty Two Only) along with further interest, all costs, charges and expenses etc. against Nandlalbhai Ghanshyambhai Parelia HUF (PAN: AAKHP5230R). The said Recovery Certificate was drawn upon failure to pay the penalty imposed vide Adjudicating Officer's order dated August 11, 2020.
