Recovery Certificate No. 4019 of 2021

Order under Rule 16 and 48 of the Second Schedule to the Income Tax Act, 1961 read with Section 28A of the SEBI Act, 1992

1. Recovery proceedings have been initiated against **Agnite Education Limited**, formerly known as **Teledata Informatics Ltd** [PAN- **AAACT2976K**] for failure to pay a sum of Rs. 8,00,000/-, respectively along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of said sum payable in respect of Certificate No. 4019 of 2021 drawn up by the Recovery Officer, Southern Regional Office.
2. A Notice of Demand dated 23/07/2021 was issued by the Recovery Officer to **Agnite Education Limited**, formerly known as **Teledata Informatics Ltd** demanding payment of the said sum along with interest, costs and expenses, within 15 days from the date of receipt of the said notice. The Recovery Officer has attached various bank accounts of the defaulters in execution of the said notice and sent/emailed copies of the attachment notice to the defaulters. The defaulter (s) have failed to pay the said dues. The funds available in the bank accounts of the defaulters are not sufficient for recovery of the dues.
3. As of today, a total of Rs 2,70,020 was collected from the defaulter following the execution of the specified notice. The Outstanding dues as on date along with further interest, all costs, charges and expenses incurred is **Rs 12,29,479/-**
4. It is learnt that the defaulters are in the possession of the below mentioned property and it is also felt that attaching the said assets would expedite the recovery proceedings.
5. In view of the above, and in exercise of the powers conferred under Rule 16 and 48 of the Second Schedule to the Income Tax Act, 1961 read with Section 28A of the SEBI Act, 1992, the defaulters are hereby prohibited from disposing, transferring, alienating or charging in respect of the following property attached:

The defaulter(s) are also hereby directed to furnish the complete details of all the movable and immovable properties held by the defaulter(s) and charges, if any, thereon in the format prescribed at **Annexure-A**, along with original title deeds pertaining to the aforementioned properties, within two weeks from date of this order at SEBI, Southern Regional Office, Chennai.
8. This order shall be served on the defaulters and **specifically** to-
 - i. The Inspector General of Registration of Tamil Nadu,
 - ii. The District Registrar, Dindigul East, Dindigul, Tamil Nadu
 - iii. The Sub Registrar, Kodaikanal Village, Tamil Nadu
 - iv. The concerned Tehsildar of the respective areas where the above mentioned property is located.
